Student Parking/Driving Rules

1. Each student wishing to park a vehicle on campus must have a valid Driver's License and must show proof of Automobile Insurance coverage.
2. Each student must purchase a parking permit for the price of \$5.00. This permit must be permanently affixed to the lower left (driver side) windshield at all times.
3. Every car is to be registered with the High School office before parking in the designated student parking area.
4. The assigned student parking lot is the only area you will be allowed to park.
5. **12th & 11th grade**– Paved parking lot East of MS/HS building and the grass area against the fence.
10th Grade – Paved parking lot behind Smiley's.
6. Violation of this policy will result in the loss of parking privilege on church/school property.
7. Safe driving is to be adhered to at all times. Speeding, careless or reckless driving will result in a referral/disciplinary action.
8. Students are to take the most direct route to the parking area.
9. Automobiles driven by students are subject to search upon reasonable suspicion.
10. Students cannot go to their cars during the day unless they have permission from the office.
11. Playing music loudly is prohibited. Florida Statute 316.3045 prohibits noise from a car that is audible at 25 feet or more. Violations will result in a referral and/or loss of driving privileges/notifying police.
12. Any change in Automobile Insurance must be immediately provided to Student Services.
13. Permits are non-transferable.
14. **Any violation of the above policies or rules will result in the temporary or permanent loss of parking or driving on campus.**
